

## Minutes of the November 15, 2009 College of Heraldry Meeting

Meeting commenced at 11:00 AM.

In attendance were: Su *Crescent*, Hrorek *Chevron*, Catherine de Winter, Jeanne Marie *Noir Licorne*, Comac *Battlement*, Ursula Georges, Theodosia of the Isles, John ap Griffin, Erikr *Gold Phoenix*, Tofi inn hvassi, Tighearnean *Coral*, Uluric de Exeforde, and Jason (Carreg Wen).

Upcoming meetings are: December 20.

Cormac wanted to personally thank the Barony of the Angels who, at their October Council meeting, colored in every single submission that came in from Great Western War.

The October 18<sup>th</sup> meeting of the College of Heraldry was cancelled due to a flood at Crescent's home.

Unless otherwise noted, all submitters will accept the creation of a holding name, if appropriate. Approved submissions will be forwarded on the January 31, 2010 Letter of Intent.

### Al-Sahid, Shire of

**Katayama Tarou Hiromoto.** Laurel Resubmission Badge: (*Fieldless*) *A Norse sun-cross argent.*

[Name] Registered 04/08.

[Armory] The device was returned on the April 2008 LoAR:

This device is returned for conflict with device of Dav Greyheart, *Argent, on a pellet a francisque (axe) Or.* There is a single CD for changes to the tertiary charge.

The charge was blazoned on the LoI as a *roundel parted per cross*. In general a CD is not granted between conjoined charges and the same charges not conjoined. If the charge had been treated as an uncharged roundel, it would have been returned for conflict with the device of Muiredach O'Siadhail, *Gyronny arrondy Or and gules, a gunstone*, having a single CD for changes to the field. As an uncharged roundel, the submitted device would also have conflicted with the device of William Hurstmonceux, *Argent, an ogress and a mountain azure*, with a single CD for removing the mountain.

This is a complete redesign.

Regarding the registerability of Norse sun-crosses as the only charge, per the October 2007 LOAR:

It has long been our standard that you while you cannot blazon your way out of conflict, you can blazon your way out of style problems. If blazoned as *a cross within and conjoined to an annulet* instead of a *Norse sun cross*, this would obviously not be a single abstract charge. Therefore it is registerable even as the only charge (or charge combination) on the armory.

**Badge is approved and forwarded to Laurel**

**Katayama Tarou Hiromoto.** Redesignation of current badge to be device.

[Name] Registered 04/08.

The submitter desires to have his current badge: *Argent, in saltire two arrow fletchings within an annulet sable.* (Registered 05/09) redesignated as his device.

**Administrative action is approved and forwarded to Laurel.**

### Altavia, Barony of

**Geneviève d'Orléans.** New Change of Device: *Ermine, on a pale vert a crescent argent.*

[Name] Registered 01/01.

[Armory] The submitter requests that if this device is registered, her registered device: *Vert, on a chevron sable fimbriated between three fleurs-de-lys a crescent argent* (04/03) be released.

**Device is approved and forwarded to Laurel.**

**Leonor de Sevilla.** New Name.

[Name] Submitter will accept minor but not major changes, and is most interested in the language/culture (Spanish). The submitter has indicated no preference as to gender of the name.

**Leonor** is a Spanish feminine name in the 16th century, found in "16<sup>th</sup> Century Spanish Names" by Elsbeth Ann Roth (<http://heraldry.sca.org/heraldry/laurel/names/spanish/fem-given-alpha.html>); it is found 16 times.

**de Sevilla** is a 15th century Spanish locative byname found in "Spanish Names from the Late 15th Century" by Juliana de Luna (<http://heraldry.sca.org/heraldry/laurel/names/isabella/locative.html>).

**Name is approved and forwarded to Laurel.**

**Monique Marie Sauniere.** New Name and New Device: *Ermine, a phoenix vert.*

[Name] The submitter desires a feminine name, allows all changes, and if the name must be changed, she cares most about the language/culture (French/Norman).

**Monique:** is a header in Dauzat p. 439 and is a Saint's name, the mother of St. Augustine. At the meeting, Ursula Green Staff found: The mother of Saint Augustine was originally *Monica*. <*Monique* is the French form of her name; Saint Augustine's mother was venerated in France as *sainte Monique* by the end of our period. Examples include a 1517 translation of Augustine's works which describes her as *sainte Monique*, quoted in Francis Higman, *Piety and the people: religious printing in French, 1511-1551* (Scolar Press, 1996; on Google Books at <http://books.google.com/books?id=fasVAQAIAAJ>). Volume 4 of the complete works of François de Sales (who lived from 1567 to 1622) mentions *sainte Monique* in a discussion of the Church Fathers' views on purgatory (p. 143) and in a list of feast days on p. 469. (*Oeuvres complètes de Saint François de Sales, évêque et prince de Genève*, Houdaille, 1836, <http://books.google.com/books?id=RdPUAAAAMAAJ>)

**Marie:** as a header in Dauzat p.416 adapted from the Hebrew Miriam and is the French form of Mary. At the meeting, it was noted that *Marie* is found 5 times in Aryanhwy merch Catmael's article "French Names from Paris, 1421, 1423, & 1438" (<http://heraldry.sca.org/names/french/paris1423.html>).

**Sauniere:** as a header in Dauzat p. 542, an orthographic form used in the Renaissance, *Lesauhier* and *Lesaulnier* are found in the North and North-West of France, meaning 'merchant or maker of salt'. *Saunière* or *Saunières* is a place where salt is made.

The names *saunier* (masculine) and *sauniere* (feminine) are found in Colm Dubh, "Occupational By-Names in the 1292 Tax Role of Paris" (<http://heraldry.sca.org/laurel/names/parisbyname.html>). *Saulnier* appears as a surname in Aryanhwy merch Catmael, "French Surnames from Paris, 1421, 1423 & 1438" (<http://heraldry.sca.org/names/french/paris1423surnames.html>) Based on these examples, *Sauniere* should be plausible as a feminine form of the byname.

[Armory] The submitter is advised to draw the ermine spots bigger. Clear of: *Argent, a phoenix vert rising from flames purple.* (Falcon Hardin, 10/2007, Ansteorra) with one CD for field, one for change of the tincture of half the charge.

**Name is approved and forwarded to Laurel. Device is approved and forwarded to Laurel.**

**Muirgen ingen Ailella.** New Name and New Device: *Per saltire argent and purple mullet of eight points argent, in pale two unicorn's heads erased sable.*

[Name] The submitter desires a feminine name and will accept all changes. Submitted as Muirgen ingen Ailill (of) Ineswytrin. The locative was dropped as Gaelic/Welsh is not registerable (Saige inghean Ghiolla Phádraig, 01/2005). We have put the patronym in the genitive.

**Muirgen** is an old Irish female given name found in OCM p.141, Borne by St. Muirgen, Abbot of Killeshin, whose feast day is 27 January.

**ingen** is a designator for 'daughter of'

**Ailill** is a masculine given name found in OCM p.17. Fourth most popular name in early Ireland.

According to the 12/2008 LoAR, "This means that the appropriate byname meaning 'daughter of Ailill' is Middle Irish *ingen Ailella*." [Ascelina Alánn ingen Ailella, A-Atenveldt, 12/2008].

**Ineswytrin** is a location found in Ekwall p.198 (s.v Glastonbury) where it is dated to 601 in that spelling; it is a Welsh spelling.

The following statement is affixed to the reverse side of the submission form: "I was unsure of the language/culture version proper of "of" – If you would be so kind as to help me. If, in order to please and fulfill the requirements of the esteemed Heraldry, there must be a deletion, I would still be most pleased with either my given name and patronym - or my given name and my locative name."

[Armory] The submitter is advised that the mullets should be drawn with longer points.

**Name is approved as changed and forwarded to Laurel. Device is approved and forwarded to Laurel.**

**Scotland of Altavia.** New name and New device: *Or, a bear sejant erect affronty gules maintaining two arrows inverted sable, on a chief azure three mullets of four points Or.*

[Name] The submitter has indicated no preferences.

**Scotland** is the submitter's legal given name. Battlement and Batonvert attest to the presence of the name on the submitter's driver's license.

**Altavia** is an SCA branch name registered in 1983.

[Armory] No conflicts found.

**Name approved and forwarded to Laurel. Device approved and forwarded to Laurel.**

#### Calafia, Barony of

**Donn O Daa.** New Name and New Device: *Or, a sword inverted the blade surmounted by a death's head on a chief vert three harps Or.*

[Name] The submitter accepts minor but not major changes, no other preferences are indicated. Submitted as Donn O'Daa. Name was changed to match the documentation found.

**Donn** is found in OCM p.75-6. "In the later medieval period Donn was a popular name among the Maguires and the O'Kennedys.

**O Daa** is found in "16th & 17th Century Anglicized Irish Surnames from Woulfe" by Mari Elspeth nic Bryan [http://medievalscotland.org/kmo/Woulfe/SortedByAnglicizedSpelling\\_O3.shtml](http://medievalscotland.org/kmo/Woulfe/SortedByAnglicizedSpelling_O3.shtml).

In [http://www.medievalscotland.org/kmo/Woulfe/SortedByAnglicizedRoot\\_D1.shtml](http://www.medievalscotland.org/kmo/Woulfe/SortedByAnglicizedRoot_D1.shtml) Mari says:

"The vast majority of Anglicized Irish forms of "O" and "Mac" style surnames listed in Woulfe that date to temp. Elizabeth I - James I are listed as O [Root] and M'[Root].

It is likely that Woulfe (or one of his sources) has normalized at least some of these names to this format since other examples from the Patent Rolls of James I found in Ewen show the formats Mc[Root] and O'[Root]."

[Armory] No conflicts found.

**Name approved as changed and forwarded to Laurel. Device approved and forwarded to Laurel.**

**Elsbeth Lyttleburye.** New Name

[Name] The submitter desires a feminine name and will accept minor but not major changes. She cares most about unspecified sound . All changes to the form are pre-submission.

**Elsbeth** is a Scottish derivative of Elizabeth. Found in the year 1539-1548. Source: "A List of Feminine Personal Names Found in Scottish Records Part Three: Post-1400 Names" by Talan Gwynek (Brian M. Scott) <http://www.s-gabriel.org/names/talan/scottishfem/scottishfemlate.html> It is also found in Withycombe, undated, as a Scottish variant of Elizabeth (s.n. Elizabeth, p.100)

**Lyttleburye** is found on a brass plate in Lincolnshire, dated 1560. Source: <http://heraldry.sca.org/laurel/names/brasses/lastnameIP.html>

**Name is approved and forwarded to Laurel.**

**Fáelán mac Áedgen.** New Name

[Name] The submitter desires a masculine name. He will accept minor but not major changes. If the name must be changed, he cares most about the meaning (wolf, fire) and language/culture (Gaelic according to the documentation section). Changes to the form are pre-submission.

**Fáelán** is a Middle Irish Gaelic (c900-c1200) name, meaning wolf. According to Donnchadh O Corrain, it is a common early name especially among the royal families of Leinster. It is also the name of St. Faelan, who was martyred in Flanders c656. Source: "Index of Names in Irish Annals: Faelan/Faolan" by Mari Elspeth nic Bryan (Kathleen M. O'Brien) <http://www.medievalscotland.org/kmo/AnnalsIndex/Masculine/Faelan.shtml> Donnchadh Ó Corráin and Fidelma Maguire. Irish Names, 2nd edition (Dublin, Ireland: Lilliput Press, 1990). p 92-93, s.n. Fáelán.  
**mac** = son of

**Áedgen** is the genitive form of Aedgen, which means "born of fire". St. Aedgen bore this name. He died 771.

**Name is approved and forwarded to Laurel.**

**Iague Margoni.** Laurel Resub Name and Laurel Resub Device: *Argent, a chevron cotised between two fleurs-de-lys and a cross of Santiago gules.*

[Name] The submitter desires a masculine name; he will accept minor but not major changes. *Iago Margoni* was returned by Laurel 10/2008 for combining Welsh and Italian. Pelican noted "We would change the name to Iague Margoni to register this as a mixed Spanish/Italian name (this would be one step from period practice), but the submitter does not allow major changes, such as changing the language of an element."

**Iague**, per the LoAR 10/2008, is from Castilla, dated to 1199 (from *Crestomatia del Español*).

**Margoni** was previously documented from "Masculine Names from Thirteenth Century Pisa" by Juliana de Luna <http://www.sca.org/heraldry/laurel/names/pisa/pisa.html>.

[Armory] The previous submission: *Bendy argent and sable, a cross of Santiago Or* was returned by Laurel, 10/2008 for conflict. This is a complete redesign. The submitter is advised to draw the fleurs-de-lys larger; the submitting herald notes she traced them from the PictDict, which is why they weren't larger.

**Name is approved and forwarded to Laurel. Device is approved and forwarded to Laurel.**

**Madeleine Ashbury**. New Device: *Purple, on a chevron azure fimbriated three fleurs-de-lys argent*.

[Armory] Name registered 11/99.

**Device approved and forwarded to Laurel.**

**Marco Solario**. Kingdom Resubmission Device: *Or, two peacocks, tails raised and spread respectant regardant proper within a bordure gules*.

[Name] This was submitted on Caid's LoI dated 09-21-09.

[Armory] His previous device submission, with the same blazon, was returned by Crescent in July 2009 for a redraw so that the peacocks were in a heraldic posture. This submission addresses that concern.

**Device is approved and forwarded to Laurel.**

**Prospero Ciriello**. New Name.

[Name] The submitter has indicated no preferences.

**Prospero**: the submitter documented Prospero from De Felice *Nomi*, p.307 where it is undated. Prospero appears 4 times in Juliana de Luna's article "A Listing of all Men's Given Names from the Condado Section of the Florence Catasto of 1427" (<http://www.s-gabriel.org/names/juliana/condado/mensalpha.html>)

**Ciriello** is found as a surname, variant of Ciro. Crescenzo Ciriello 1505. (Minervini, *Dizionario dei Cognomi Pugliesi*, p. 150.)

**Name is approved and forwarded to Laurel.**

**Rosetta la Firenza**. New Name and New Device: *Per bend purple fretty Or and argent, in base three roses purple*.

[Name] The submitter will accept all changes and requests an authentic name for the Italian language/culture.

**Rosetta** is a constructed feminine Florentine given name. The name <Rosa> appears 21 times in Juliana de Luna, "A Listing of all Women's Given Names from the Condado Section of the Florence Catasto of 1427 by Juliana de Luna (Julia Smith)" (<http://www.s-gabriel.org/names/juliana/condado/womensalpha.html>). The same source includes multiple examples of feminine given names using the diminutive suffix <-etta>, including <Giuletta>, <Dioletta>, <Benedetta>, <Isabetta>, and <Vegnetta>.

**la Firenza** is a surname meaning "The Florentine," from Minervini, *Dizionario dei Cognomi Pugliesi*, p.207, s.n. Firenze.

**Name approved and forwarded to Laurel. Device approved and forwarded to Laurel.**

**Samthann ingen Gharbáin**. New Name and New Device. *Argent, three penners and inkhorns azure*.

[Name] The submitter desires a feminine name and will accept all changes. If the name must be changed, she cares most about the unspecified language/culture. She requests authenticity for 7<sup>th</sup> C Irish language/culture.

**Samthann** is a feminine Irish given name found in OCM p.161, which cites: St. *Samthann* died in 739.

**ingen** designator for 'daughter of'

**Gharbáin** is found in Woulfe, p. 187, as the lenited form of *Garban*. *Garban* is found in OCM p.110. "Index of Names in Irish Annals: Garbán" (Mari Elspeth nic Bryan, <http://medievalscotland.org/kmo/AnnalsIndex/Masculine/Garban.shtml>) indicates that *Gharbáin* is the Old Irish Gaelic genitive form of Garbán.

[Armory] This depiction of a penner and inkhorn is taken from the *Pictorial Dictionary*; the charge is dated to 1530.

**Name approved and forwarded to Laurel. Device approved and forwarded to Laurel.**

**Uluric de Exeforde**. Resubmission Device: *Per saltire gules and azure, a saltire Or between two lions passant guardant and two fleur-de-lys argent*.

[Armory] The submitter's current device is in submission at Laurel, the decision on it will be made at the December Wreath meeting. Crescent declines to accept a resubmission that has not yet been officially returned by Laurel.

**Device is returned for administrative reason.**

**Darach, Shire of**

**Arabella da Siena.** New Household Name: **House of Cavalla**, and New Badge: *Per chevron sable and gules, a chevron rompu and in base a chamfron Or.*

[Name] Name was registered January 1997.

No preferences have been indicated.

**Cavalla** is an Italian surname found in "Dizionario dei Cognomi Pugliesi," Prof. Maria Giovanna Arcamone, 2005, ISBN 88-8229-527-3, under Cavalli, an alternate spelling of Cavallo; Don Pietro Cavallo – 1595.

This household name follows the pattern: House of Surname.

[Armory] The badge is to be associated with the household name. The submitter is advised to draw the chamfron bigger.

**Name approved and forwarded to Laurel. Badge approved and forwarded to Laurel.**

**Bruce Draconarius.** New Badge: *(Fieldless) An orb Or.*

[Name] Registered 04/91.

[Armory] From "Master Bruce's Introduction to Remarkably Obscure Charges" (unpublished): "The orb. Like the scepter, it was held by a sovereign as a symbol of authority – in fact, many monarchs' portraits showed them holding both. Its form was a sphere with bands – said to represent the equator and northern meridian – with the cross watching over all. The orb's found in the arms of Friellas, c.1540 [Livro de Nobreza, fo.23v], and of Fleckensteiner, 1605 [Siebmacher 200]."

This conflicts with *Gules, an orb Or*, (Arch-Steward of the Holy Roman Empire, December of 1994.)

**Badge is returned for conflict.**

**Ismay of Giggleswick.** New Alternate Name: *Ása íkorni*

[Name] Name was registered July 1999. The submitter indicated no preferences

Submitted as *Ása íkorni*, since accent marks must be used consistently, we have added the accent to the initial A.

*Ása* is found in Geirr Bassi, as a feminine given name on p. 8.

*íkorni* is grandfathered to the submitter, who registered *Ljúfvina íkorni* (January 2008.)

**Name is approved and forwarded to Laurel.**

**William the Bowman.** New Name

[Name] The submitter desires a masculine name, will accept minor but not major changes and if the name must be changed he cares most about the unspecified sound.

**William** is a header spelling in Withycombe p.293, where it is noted that the name was introduced to England in the 11th century and became one of the commonest names in England.

**Bowman** is a header spelling in Reaney & Wilson p. 57-8, dated in this spelling from 1279.

Concern was expressed that this name might conflict with William Bowman, the 19<sup>th</sup> century ophthalmologist, who is listed in the Encyclopedia Britannica. This name is submitted, for the College of Arms to address this concern.

**Name approved and forwarded to Laurel.**

**Dreiburgen, Barony of**

**Kukhmistr Zhuk.** New Name.

[Name] The submitter desires a masculine name, will accept only minor changes, and cares most about the meaning "cook" and language/culture: Russian.

**Kukhmistr** is found in Wickendon, 3<sup>rd</sup> ed. p. 173.

(m) "cook" Kukhmistr Vozhik, southwesterer 1399.

Pats – Baraban Kukhmistrov, craftsman, 1552

Podobekh Kukhmistrovich, Chernobyl, craftman, 1552.

**Zhuk** is found in Wickendon 3<sup>rd</sup> ed. p. 421

(m) – 'beetle'

Gregorii Zhuk – 15<sup>th</sup> cent.

**Name is withdrawn by the submitter.**

**Fujioka Tora.** New Name Change:

[Name] Her current name *Luighseach nic Lochlainn* was registered 01/1996 via Caid. The submitter desires a feminine name and will accept minor but not major changes. If the name must be changed she cares more about the meaning of the surname (wisteria hill) and the language (Japanese). If Fujioka Tora is registered, her previous name *Luighseach nic Lochlainn* is to be retained as an alternate name.

All documentation from Name Construction in Medieval Japan by Solveig Thronardottir, 2nd ed (1999).

**Tora** - p. 154 (s.v. Tiger, under celestial phenomena); feminine name dated 1572.

**Fuji** - p. 161 (s.v. Wisteria, under Plants); found as a prototheme in surnames. Examples Fujii - Wysteria Well and Fujiwara - Wysteria Plain. Both are also found under Historical Surnames, Fu. They are dated 1147 and 784 respectively.

**Oka** - o, 145 (s.v. Hill, under Works of Nature) found as deutotheme in surnames. Examples include Imaoka, Kataoka, Nagaoka, Yamaoka.

Fujioka, wysteria hill, seems to be a reasonable construction given wysteria plain and wysteria well.

**Name is approved and forwarded to Laurel.**

#### **Gyldenholt, Barony of**

**Alys de Montcharmout.** New Name and New Device: *Azure mullet, on a bend argent a mountain range vert.* [Name] The submitter desires a feminine name, she will accept all changes. If the name must be changed, she is most interested in unspecified sound.

**Alys** is a header in Withycombe p.16, dated to the 15th century.

**Montcharmout** is in Dauzat p.706, a common name of St. Prix. It is a locative found in *Mémoires By Société éduenne des lettres, sciences et arts* (1602) p. 34: "Johan de Montcharmout."

[Armory] A mountain range is found on plate 46 of Siebmacher, in the arms of Siebenbürger:

**Name and device are approved and forwarded to Laurel.**

**Jakob Hálfðanarson.** New Name

[Name] The submitter desires a masculine name. He will accept minor but not major changes, and if changes must be made cares most about the language/culture 12<sup>th</sup> Century Danish, and meaning: Jakob son of Hálfðan. He request authenticity for 12<sup>th</sup> C. Danish. Since the name is registerable as submitted, the College was not concerned about narrowing the focus to 12<sup>th</sup> century Denmark.

**Jakob** is found in Geirr Bassi, pg. 12.

**Hálfðan** is found in Geirr Bassi, p. 11.

The patronymic was formed based on the directions in Geirr Bassi.

**Name is approved and forwarded to Laurel.**

**Jethro de Calce des Excurtynyx.** New Name and New Device: *Gyronny gules and Or, a double-headed eagle sable within a bordure counterchanged.*

[Name] Submitter desires a masculine name, will accept minor but not major changes, and cares most about having a 15th century Swiss name.

**Jethro** is a biblical name which appears in Genesis, and is Moses's father-in-law.

From precedents:

*Jethro* is one of the Biblical names that came into use in England after the Reformation. J. W. Garrett-Pegge, *A Transcript of the First Volume, 1538-1636, of the Parish Register of Chesham, Buckingham County* (p. 120) records the baptism of "Jethro sonn of Rowland & Martha Peirce" on December 28, 1615. Also, Argent Snail found the name *Jethro* in Bardsley's *Curiosities of Puritan Nomenclature* (p. 101). She quotes this source, "'Jethro Forstall obtains licence, November 12, 1604, to dwell in one of the alms-rooms of Canterbury Cathedral.' That is obviously something granted to an adult, which makes the name having been used pre 1600." [Jethro Stille, 05/2002, A-Outlands]

**de Calce des Excurtynyx** is found in 15th c. men's names in Latin from Payerne, Switzerland, by Aryanhwych verch Catmael. <http://www.ellipsis.cx/~liana/names/swiss/payerne.html>

[Armory] No conflicts found.

**Name and device approved and forwarded to Laurel.**

**Meghan ferch Morgan.** New Name and New Device: *Sable, a wolf statant guardant argent in chief a lantern between two roses Or.*

[Name] The submitter desires a feminine name, will accept minor, but not major changes, and cares most about the unspecified sound.

**Meghan** is the submitter's legal given name as shown on her college ID, attested by Bruce, *Batonvert*.

**ferch Morgan** – "daughter of Morgan" Morgan is found in "Simple Guide to constructing 16<sup>th</sup> century Welsh Names" by Heather Rose Jones.

Cover Letter to the 09/2003 LoAR states what kinds of ID are acceptable. The College of Heraldry considered that college ID is not required to show Legal Name. Su *Crescent* has known Meghan her entire life and attests that Meghan is the submitter's legal given name.

[Armory] The lantern looks lower than the two roses, so this device is returned for a redraw. Note: this device was redrawn by Crescent and so is forwarded.

**Merewen** is found in Talan Gwynek's "Feminine Given Names in a Dictionary of English Surnames." It also appears in R&W on pg 301 s.n. Marvin, which cites it as a feminine name in 1202.

**Warthwic** is listed as an old name for Warwick. *A Dictionary of British Place-Names* by Mills has "Warwick. Warthwic 1131. "Dwelling or farm on the bank". OE waroth+wic. Ekwall, p. 499 (s.v. Warwick), dates Warthwic to 1132.

**Tofi inn hvassi.** New Name and New Device: *Per chevron Or and gules, two phoenixes gules and a fountain.*

[Name] The submitter desires a masculine name, will accept minor but not major changes, and cares most about the meaning 'not dumb'.

**Tófi** is found in Geirr Bassi p. 14 as a masculine given name. The submitter does not wish to have the accent.

**inn hvassi** is found in Geirr Bassi p. 23 meaning 'the sharp, the keen.'

**Alana Buchanan.** New Badge: *(Fieldless) A rose purpure within and conjoined to an annulet argent.*

[Armory] Name was registered November 1997.

**Aliskye Rosel.** New Name Change and New Badge: *(Fieldless) A squirrel sejant erect contourny crowned of a pearled coronet and maintaining an acorn argent.*

[Name] The submitter desires a feminine name and will accept minor but not major changes. No other preferences are indicated.

**Grace** is a feminine English given name found in Withycombe p.138, "Grace Chester, 1562."

**Bywater** is an English surname found in Reaney and Wilson, p.78, as the header spelling: "dweller by the water." Bardsley, p.154, "Lawrence Bywater, buried 1597-8."

[Armory] This stag is not centered and the gouttes are of differing sizes; both are grounds for return. NOTE: if the redraw is received by the next meeting, it will be forwarded to Laurel with the submissions from this month. Note: this was redrawn by Crescent and submitted at the same time as the name.

**Name is approved and forwarded to Laurel. Device is approved and forwarded to Laurel.**

**Naevehjem, Barony of**

**Geneviève Chapeliere de Soie.** New Device: *Argent, on a bend purpure between two ravens sable three fleurs-de-lys Or.*

[Armory] Name was registered May 2006. Form was changed to match the registered form. Note: Fleurs should be blazoned as palewise.

**Device approved and forwarded to Laurel.**

**Kristian sindri.** Resub Kingdom Device: *Per bend sinister vert and azure, a bend sinister wreathed gules and Or between a falling star bendwise sinister Or and a comet bendwise sinister argent.*

[Armory] Name was registered May 2006. Name on form was changed to match the registered form. His previous submission, *Per bend sinister vert and azure, a bend sinister torted Or and argent between a comet Or and a comet inverted argent*, was returned by Crescent in Oct. 2007 for low contrast (the bend sinister cannot be two metals). Changing the tincture removes this problem.

From the PicDic: (s.n. comet) some SCA blazons use *shooting star* or *falling star* to refer to a comet with its head to base -- i.e., a comet inverted.

**Isabele de Ueupunt.** New Name and New Device: *Purpure, a pair of scissors and a gore Or.*

[Name] No preferences are indicated on the submission form. All changes to the form were done by the submitter before submission.

**Isabele** is found in Withycombe p.164 (s.n. Isabel(la)), dated in this spelling to 1196.

**de Ueupunt** is found in Black p. 795 (s.n. Vipont), dated in this spelling to 1165.

[Armory] We note the registration of Maudeleyn Godeliva Taillour. Badge. (*Fieldless*) *A pair of open scissors Or.* "Nice badge. We note that scissors have their points to chief by default, unlike shears which have their points to base." These are scissors, and are therefore in their proper orientation.

**Name and device are approved and forwarded to Laurel.**

**Starkhafn, Barony of**

**Alexandra Sinclair.** New Name and New Device: *Azure, two wolves sejant respectant ululant in chief a decrescent argent.*

[Name] The submitter desires a feminine name, will accept all changes, and cares most about the sound of the name.

**Alexandra** is found in Withycombe, p. 14 (s.n. Alexandra), cited as 'found in England in 1205. May have been named after the 4<sup>th</sup> C martyr.'

**Sinclair** is a surname found in R&W, 3<sup>rd</sup> edition, p. 411, as a header spelling "The Sinclairs of Caithness appeared in Scotland c. 1124-53." Note: this is actually a name change from *Alexis Davis*, registered 01/06.

[Armory] Clear of: *Azure, a shakefork between a decrescent and two wolves sejant respectant ululant argent.* (Catherine Eccles, 10/89) with an X.2 difference between a shakefork and two wolves. The posture "ululant" is considered a step from period practice.

This device was copied and colored at the meeting. Please do not send in submissions on cardstock. It changes appearance of tinctures. Also, colored photocopies are acceptable by the Caid College of Arms on a case by case basis. Note: this is actually a change of primary device: *Purpure, on a bend sable fimbriated a tree palewise argent*, registered 01/06.
