

Minutes of the May 16, 2010 College of Heralds Meeting

Meeting commenced at 11:00 AM.

In attendance were: Su *Crescent*, Illuminada *Dolphin*, Cormac *Battlement*, Martin Monteyro do Monte, and Ursula *Green Staff*.

Upcoming meetings are June 20th, July 18, Aug 15, Sept 12, Oct 3, Nov 21, and Dec 19.

Unless otherwise noted, all submitters will accept the creation of a holding name, if appropriate. Approved submissions will be forwarded on the May 31, 2010 Letter of Intent.

Angels, Barony of the

Morgaine FitzStephen New Badge: *Vert, a coronet Or enfiled of a sword inverted proper.* Morgaine FitzStephen, name was registered 5/86.

She received a court barony in Caid on 9/13/2008, when she stepped down as Baroness of the Angels, and is thus entitled to a coronet in her armory. This will be Morgaine's sixth piece of registered armory.

This conflicts with: *Vert, two claymores in saltire surmounted by a third inverted proper, enfiling a ducal coronet Or.* (Deaton Claymore (device, Sept. 1994 via Atenveldt), with only One CD for the number of swords.

Device is returned for conflict.

Dreiburgen, Barony of

Ívarr Sigurðarson. New Badge: (Fieldless) Three runes (Algiz / Thurisaz / Nauth) conjoined in pale sable.

Ívarr Sigurðarson was registered March 2004.

This must be returned for running afoul of the longstanding ban on abstract symbols as sole charges, recently upheld and expanded on the LoAR of March 2006:

There has long been precedent against armory consisting of a single abstract charge -- symbols that represent a phoneme or meaning, such as letters, numbers, runes, and kanji -- as well as against the registration of monograms. The rationale has been to prevent one submitter from having exclusive right to a symbol which should be commonly available to all. That rationale would, we feel, also apply to phrases made up from multiple abstract charges, if those are the sole elements of the armory. Thus, as we should not accept Argent, the letter L sable or Argent, in fess the letters LO sable, we should not accept Argent, the word LOVE sable. The same argument applies here: we cannot accept a design consisting solely of kanji. We therefore extend the ban on single abstract charges to cover any armory consisting solely of abstract charges, in any language (e.g., Japanese kanji, Norse

runes, Arabic script, etc.). This applies whether the armory consists of a single word or a phrase. [LoAR March 2006, Returns, s.n. Yamahara Yorimasa]

Runes were usually inscribed onto a 2- or 4-sided object such as a staff, sword or stone. If the submitter resubmits this on another charge that isn't an ordinary or subordinary, we suggest that he try one of these.

Badge returned for further consultation. Illuminada will consult.

Naevehjem, Barony of

Mirabilla Starre New device: *Vert mullety, a tree eradicated argent and a bordure compony azure and argent.*

Name registered 11/09.

The leaves could be more prominent and the border could be thicker, but these issues are not sufficient to require a return.

No conflicts were found.

Device is approved and forwarded to Laurel.

Wintermist, Shire of

Katherine of Hornechurch Name change (from Holding Name)

Katherine of Wintermist was registered as a holding name 04/08, for the submission Katherine of Judgement Keep.

The submitter desires a feminine name and will accept minor, but not major changes. No other preferences are indicated.

Katherine is found in Talan Gwynek's "Feminine Names in the Dictionary of English Surnames," http://heraldry.sca.org/laurel/reaneyHZ.html, s.n. Katharine, dated in this spelling: 1316 (Curzon); 1325 (xl); 1392 (Bathurst); 1510 (Wenborn); 1516 (Chipperfield); and 1597 (Elesender).

Hornechurch is found in Ekwall s.n. Hornchurch, Hornedecherche 1311, glossed as 'Horned church' i.e. 'church with horn-like gables." The name is also found in this spelling: "*John Legatt* of Hornechurch Hall in the parish of Hornchurch, Essex, gent." It is cited in a discussion regarding an inquisition in 1592.
