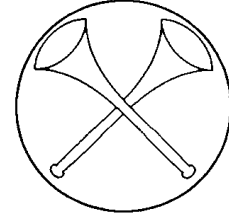

### Minutes of the November 13, 2011 meeting

Meeting commenced at 11:00.

In attendance were: Cormac *Crescent*, Jeanne Marie *Dolphin*, Mary *Bellows*, Eridana *Trident*, Thomas *Quatrefoil*, Eirikr *Gold Phoenix*, Hrorek *Chevron*, Ariana, Magdalyn Tynkere *Al-Sahid*, Moirin Chiardhubh ni Bhardain *Wintermist*, Catherine de Winter, and Maria (Magdalyn's guest).

Tentative schedule for the rest of the year: Dec 11<sup>th</sup> (party). The 2012 schedule will be posted as soon as possible.

Approved submissions were forwarded to Laurel on the November 13, 2011 Letter of Intent.

#### Society News:

- The polling results in Gyldenholt for the proposed heirs to the barony, Baron Giles Hill, *Silver Trumpet*, and Baron Giuseppe Francesco da Borgia, were announced at Coronation. Giles and Giuseppe received 90% approval, and will be installed next year as Reeves, and later on as Barons.

**From the LoARs:** The September LoAR was published October 8<sup>th</sup> and is available at <http://heraldry.sca.org/loar/2011/09/>. Everyone is encouraged to read both the Cover Letter and the LoAR. The September 2011 LoAR contains results from Caid's June 22<sup>nd</sup> and June 29<sup>th</sup> Letters of Intent.

- From Pelican: Some Name Resources deals with Welsh names.
- Pelican is asking for comments on byname presumption. For examples should Isaac Masters be registerable?
- Wreath is asking for comments on modifying maintained/sustained treatment.
- *Aurora* has been found as a grey period Italian feminine name.
- The mixture of Dutch and French is no longer a SFPP.
- Pelican writes: "We remind commenters and submissions heralds that the information we have available on Welsh names is derived from different sorts of documents with different levels of Anglicization and Latinization. Much of the variability we see in dated forms, then, is linguistic rather than temporal. For that reason, forms that follow Welsh spelling conventions should not be dismissed as inauthentic because the most accessible dated forms are heavily Anglicized."
- The use of standing balances has been ruled a SFPP. No difference is granted between a standing and a hanging balance (also known as scales).
- Clarification of precedent: The tincture of irises is taken from their blossom, not their leaves.
- No difference is granted between a moose (European elk) and a deer, a stag, or a doe.

#### From Crescent:

- Congratulations to Mistress Caitlin Cristina Wintour, who has been named Golden Rose, Their Majesties' personal herald for the duration of Their reign.
- The Caid Roll of Arms will soon be removed from the Caid website, pending further notice. There have been substantial problems with depictions & it begins to affect the ability of groups such as the College of Scribes to successfully complete their tasks.

#### **From Dolphin:**

- As a reminder, a name change to a form Laurel recommended can be submitted as a request for reconsideration (no charge).
- Please send in summaries. This makes meetings go much more swiftly and smoothly, as well as making it easier for us to start on time. The online form is highly discouraged. It is not coping with accented characters of any type. If you use it, please use Da'ud notation. #### **November Submissions**

**Bako Miklós.** New Name and New Device. *Per bend purpure and azure a peacock close to sinister regardant argent*

Submitter desires a masculine name & has indicated no other preferences. He included the pronunciation (Meek-losh Ba-ko). Name submitted as **Miklos Bakó**. Per a phone conversation, he preferred changing the order of the names to make it more authentic. The accent on the surname was dropped to match the documentation.

**Miklós** is found as a common masculine given name in "Hungarian Names 101" by Walraven van Nijmegen (<http://heraldry.sca.org/laurel/names/magyarnames1012.html>).

**Bako** Bak{o'} from Kazmer, s.n. Bak{o'}. The entry reads: Bak{o'} 1401: Clementem Bako (ZichyOkm. 4:233), 1410: Bako {empty set} (Fej{e'}r m. 360), 1411: Valentinus Bakow ~ Bako (Hoint vm. 149), ... and continues with dates for the form without the accent at least every three decades through post-period, dating the form Bak{o'} first in 1687. Other dated forms Bakoh, Bhako, bako, Bakho, and Boko.

Typical name order is surname-given name in Hungarian and given name-surname when recorded in Latin. The submitter prefers to change the name to support the Hungarian pattern.

Device conflicts with (*Fieldless*) *A peacock pavanated to base contourney argent* (Barony of the Thousand Eyes, 1997, Artemisia)

**Name approved as changed and forwarded to Laurel. Device is returned for conflict.**

**Catrin Aderyn.** New Name and New Device. *Purple two chevronels and in base a dragon sejant erect contourney argent*

The submitter desires a feminine name and will accept minor but not major changes. If the name must be changed she cares most about the sound (unspecified).

**Catrin** is found in the IGI within period as follows:

**Aderyn** is found in *Foedera, conventiones, literae et cujuscunque generis acta publica inter ...* By Thomas Rymer, Robert Thomas Sanderson ([http://books.google.com/books?id=HV0\\_AAAAcAAJ](http://books.google.com/books?id=HV0_AAAAcAAJ)), published in 1617. The index of names, on p. 681, lists Adam Aderyn. We were unable to find the name in the book (it appears to be referencing a different volume) but it is clearly a surname as of 1617.

**Name is approved and forwarded to Laurel. Device is returned for redraw.**

**Colette Olivier la fourniere.** New Badge. (*Fieldless*) *In saltire an arrow inverted sable and a stalk of wheat Or overall a bunch of grapes proper*

The submitter's name was registered July 2011.

Per precedent:

[A hammer and tongs in saltire, overall a sword] "Contrary to opinion expressed in the LoI, this is indeed slot machine heraldry, in violation of RFS VIII.1.a. It contains three disparate charges in a standard heraldic arrangement." (LoAR 12/91 p.16).

The charge group described in the returned armory above resembles a sheaf of tools/weapons. This submission is not a sheaf, nor any other standard heraldic arrangement of charges in the same charge group. Therefore, it is the opinion of the Caid College of Heraldry that this armory is not slot-machine, and is therefore registerable.

**Badge approved and forwarded to Laurel.**

**Dragonet de La Rochelle.** New Device. *Vert, in pale a natural dolphin embowed argent and a compass rose Or.*

The submitter's name was registered September 2011.

The use of a natural dolphin is no longer a SFPP. Recent precedent considered the habitat of the natural dolphin and declared, "...Therefore, the use of a natural dolphin is not a step from period practice, - Ruaidhri mac Seamuis, 4/2011" Concerning the compass rose, precedent states the following: "While the use of the compass star is a step from period practice, the use of a compass rose is not. - Sebastian von Aterdorff, 3/2011."

**Device approved as submitted and forwarded to Laurel.**

**Juliana de Lyndewode.** New Name and New Device. *Purpure, on a bend between two feathers bendwise argent three sprigs of ivy vert*

The submitter desires a feminine name and allows minor but not major changes. If the name must be changed she cares most about the sound, language and culture. She wants as close to "Julie" in Anglo-Norman as she can get. Submitted as **Juliana de Lyndewod**; we have expanded the byname.

**Juliana** is found as a feminine given name in "Feminine Given Names in A Dictionary of English Surnames" by Talan Gwynek (<http://heraldry.sca.org/laurel/reaneyHZ.html>).

**de Lyndwode** is found as John de Lyndewod' on "An Index to the 1332 Lay Subsidy Rolls for Lincolnshire, England" by Mari Elspeth nic Bryan (<http://www.s-gabriel.org/names/mari/LincLSR/GivJ3.html>). The apostrophe indicates a scribal abbreviation, the name is most likely de Lyndwode; we have changed the name as scribal abbreviations are not registerable.

**Name is approved as changed and forwarded to Laurel. Device is approved and forwarded to Laurel.**

**Michael mac Michael.** New Name.

The submitter has indicated no preferences; however, the submitting herald states that he has expressed an interest in the sound.

**Michael** is found in Withycombe (s.n. Michael) where it is dated in this spelling to 1195-1215, 1218, 1303 and 1346. Julian Goodwyn's "English Names from pre-1600 Brass Inscriptions" (<http://heraldry.sca.org/laurel/names/brasses/men.html>) dates Michael to 1518.

**MacMichael** is found in Black (s.n. MACMICHAEL, p. 542) with the dated examples include John Makmychell, burger of Prestwick, 1507. Johannes McMichell, king's tenant 1527. The August 2002 LoAR (v. Seth MacMichael) states:

Listed on the LoI as *Seth MacMychel*, this name was submitted as *Seth MacMicha~~e~~l* and changed at Kingdom to use a byname form documented to 1490 in Scotland to meet the submitter's request for authenticity for Scotland. Black (p. 543 s.n. MacMichael) dates the bynames *M'Ilmichael* to 1577 and *McMychel* to 1490. Given these examples (and others listed in this entry), the submitted form is reasonable as an authentic form for late period Scotland. Therefore, we have returned the byname to the submitted form.

**Name approved and forwarded to Laurel.**

**Nikolaus Grunewaldt.** New Name and New Device. *Or, a chevron inverted cotised gules, in chief a dragon passant sable surmounted by a crescent gules*

The submitter is interested in a masculine name and allows all changes. If the name must be changed he is most interested meaning and language and/or culture (unspecified). Name submitted as **Nikolaus Grünenwaldt**. Name has been changed to match the documented form.

**Nikolaus** is found in <http://www.s-gabriel.org/names/talan/germmasc/> as follows:

Plauen

The following tables list the most frequent men's names from the area around Plauen (in what was East Germany, at its common border with Czechoslovakia and the former West Germany). I have combined records from the four towns with those from the surrounding villages and countryside. The total number of persons named is 1280 for the earlier period; for the later it is 4204. The data are taken from Hellfritzsich.

**Grunewaldt** is found in Bahlow, p 189 under Grunewald and dates to 1322. We were unable to find the spelling as the submitter desired it, and have changed the spelling match the documented form.

The submitter has permission to conflict with his father, Eadwynne of Runedun (device, Nov. 1982), *Or, a chevron inverted cotised gules, in chief a dragon passant sable.*

**Name is approved as changed and forwarded to Laurel. Device approved and forwarded to Laurel.**

**Orion Martyn.** New Device. *Per saltire sable and vert, an annulet of ivy vine and in base three mullets of four points in fess argent.*

The submitter's name was registered July 2010.

**Device approved and forwarded to Laurel.**

**Sólveig háleggr Jóhansdottir.** New Name and New Device. *Or, a frog vert and on a chief sable a Thor's hammer Or*

Submitter prefers a feminine name and allows all changes. Submitted as **Sólveig H{a-}leggr J{o-}hansdottir** the byname has changed to haleggr in accordance with precedent on capitalization of Norse bynames and have changed the accents to match the documentation.

All of the names are documented from Geirr Bassi.

**Sólveig** is found on p. 14 as a feminine given name.

**háleggr** is found on p. 22 as a nickname meaning "high-leg, long-leg".

**Jóhann** is found on p. 12 as a masculine name. The patronymic is formed in accordance with the guidelines on p. 17.

Norse names may be registered without the accents as long as the use (or not use) of accents is consistent.

**Name approved as changed and forwarded to Laurel. Device approved and forwarded to Laurel.**

**Tatiana Dragon.** New Name.

The submitter desires a feminine name and has indicated no other preferences.

**Tat'iana** is found as a feminine given name in "A Dictionary of Period Russian Names" by Paul Wickenden of Thanet (<http://heraldry.sca.org/paul/>) where it is shown as "Tat'iana, martyr. 1356. [Lev 3]" Tatiana is listed as a variant of the name in the same document.

**Dragon** is found in the same source as a masculine given name dated to 1052. It is used here as an unmarked patronymic

In the September 2007 Cover Letter the section "From Pelican: Unmarked Patronymics in Russian Names" concludes "This list supports the statement by the experts that unmarked patronymics are found but are rare.

Given this, we feel that it is reasonable to allow the registration of unmarked patronymics in Russian names. However, it should be noted that this practice is rare at best, and should be discouraged."

**Name is approved and forwarded to Laurel.**
