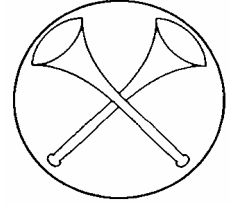

Minutes of the September 13, 2015 Meeting

Meeting commenced at 11:00 AM.

Approved submissions were forwarded to Laurel on the September 30, 2015 Letter of Intent.

Society Notes: Master Lot Ramirez was offered entry to the Order of Defense and Master Thomas Brownwell was offered membership in the Order of the Pelican.

September Submissions

Anastasia Sabina (Wintermist) - New Name & New Device. *Per pale Or and gules, a phoenix between three mullets of four points all counterchanged.*

Submitter desires a feminine name.
No major changes.
Sound most important.

Anastasia is a feminine Roman name dated between 527 and 641 and found in "Common Names of the Aristocracy in the Roman Empire During the 6th and 7th Centuries" by Bardas Xiphias (http://heraldry.sca.org/names/byzantine/early_byz_names.html)

Sabina is the feminine form of Sabinus, a Roman cognomen found in "A Simple Guide to Imperial Roman Names" by Ursula Georges at <http://heraldry.sca.org/names/roman.html>

This can also be documented as a late period Spanish name from FamilySearch Historical Records:

Submitted as *Per pale gules and Or, a phoenix between three mullets of four points all counterchanged*, this device conflict with Cassadoria Finialla: *Per pale gules and Or, a phoenix counterchanged* (East, March 1994). There is only one DC for the addition of the secondary charges, the mullets of four points. With the submitter's approval, the colors were swapped, clearing this conflict.

Angharat Goch verch Gwenhover (Lyondemere) - Laurel Resub Badge. (*Fieldless*) *A stag's attire fesswise argent.*

The submitter's previous submission of the same badge will be returned administratively by Wreath on the September 2015 LoAR because the emblazon on the LoI didn't match the emblazon on the form. This problem was noted at the end of commentary.

Badge approved and forwarded to Laurel.

Cristabel Danuers (Calafia) - New Name & New Device. *Per saltire argent and purple, a cross moline disjointed counterchanged.*

Sound (no preferences marked) most important.

Cristabel is a English feminine given name found in FamilySearch Historical Records, including:

Danuers an English surname found in R&W under the heading Danvers dated to 1230 as *Ralph de Anuers, Danuers*, meaning from Antwerp. It is also found in FamilySearch Historical Records, including:

David Lennox Hamilton (Dreiburgen) - New Name Change & New Device Change. *Dawid Radzowycz. Per chevron azure and argent, two fleurs-de-lys argent and a mullet gules.*

Submitter desires a masculine name and allows no changes. Culture (Polish-Lithuanian Commonwealth, late 15th Century) most important.

Dawid is a Polish masculine given name found in "A Preliminary Survey of Names from the Historical Dictionary of Personal Names in Bialystok" in the KWHSS 2011 Proceedings and dated to 1521.

Radzowycz is a Polish family name found in *Slownik Staropolskich Nazw Osobowych* by Witold Tasycki and dated to 1443.

His current device, *Per chevron azure and argent, two fleurs-de-lys argent and a thistle proper*, registered Feb 1991, is to be released.

Name change approved and forwarded to Laurel.

David Lennox Hamilton (Dreiburgen) - New Badge. (*Fieldless*) *A sinister wing couped sable.*

This is clear of both Wulfhere Mannteufel, *Erminois, within and maintained by an eagle's wing with a talon issuant sable, a goblet argent* (August 2005, Meridies) and Roger Fitzlyon, *Argent, a dexter wing conjoined at the base with a sinister gauntlet sable maintaining a sword gules* (November 1987, An Tir). In both cases, there is a DC for the field and even if the maintained charges grant no difference, by precedent there is difference between a dexter and a sinister wing (Barony of Windhaven, February 2010, Northshield-A).

Badge approved and forwarded to Laurel.

Eibhlin an Ucaire (Calafia) – Kingdom Resub Badge. (*Fieldless*) *A sword inverted proper between and grasped by two dragons combatant sable and gules.*

This is a kingdom resubmission from Oct 2014. The original design had the tails wrapped around the sword and made it difficult to identify. This redraw has corrected the problem

There were some members of the College who had concern about the identifiability of the design, fearing that it could appear as a winged sword.

Emma Rose de Harfleur (Gyldenholt) - New Badge. (*Fieldless*) *A cross moline argent overall a rose proper.*

Badge approved and forwarded to Laurel.

Enedina Lacarra de Navarre (Calafia) - New Badge. (*Fieldless*) *A talbot statant contourny sable charged at the shoulder with a paw print Or.*

The use of a paw print is a Step from Period Practice.

Badge approved and forwarded to Laurel.

Enedina Lacarra de Navarre (Calafia) - New Badge. (*Fieldless*) *A talbot statant contourny sable charged at the shoulder with a paw print argent.*

The use of a paw print is a Step from Period Practice.

Badge approved and forwarded to Laurel.

Geneviève of Raveley (Angels) - New Name.

Submitter desires a feminine name and allows all changes. If the name must be changed, Language/Culture (Not specified) is most important.

Geneviève is a French feminine given name listed in An Index to the Given Names in the 1292 Census of Paris by Colm Dubh (<http://heraldry.sca.org/laurel/names/paris.html#G>)

Raveley is the modern *lingua Anglica* form of a town in Cambridgeshire, documented in Watts, p. 493, with the spellings *Rauelai* dated to 1163 and *Ravele(ye)* dated to 1273.

SENA Appendix C allows for French and English to be combined in this way.

Name approved and forwarded to Laurel

Heinrich Augustein von Helden (Wintermist) - New Badge. (*Fieldless*) *In pale a squirrel Or maintaining an acorn proper atop an anvil sable.*

Despite the squirrel crossing the fess line, we believe that the relative visual weights of the two charges makes them co-primary.

Badge approved and forwarded to Laurel.

Magdalena Hungerford (Calafia) - New Name & New Device. *Per saltire vert and Or, a Hungerford knot counterchanged.*

Sound (no preferences marked) most important.

Magdalena is an English feminine given name found in FamilySearch Historical Records, including:

Manus le Dragonier (Wintermist) - New Alternate Name & New Badge. *Cross of Caid. (Fieldless) Four crescents conjoined in saltire, horns outward, azure.*

Cross is an English masculine given name found in FamilySearch Historical Records:

- Cross Batton, chr. 10 May 1619, London, England, Batch P00145-1 (<https://familysearch.org/ark:/61903/1:1:NPKR-KBJ>)

Caid is the registered name of an SCA branch, registered February 1975. The locative is formed allowed by SENA PN.1.f.

This does not run afoul of SENA PN4E, Claim of Nonhuman Status, as Cross of Caid is not "a territorial name, a rank or title, or an order or award" nor is it a "non-personal entity we protect".

Tanwayour, Canton of (Calafia) - New Badge. *(Fieldless) An open scroll sable overall two scimitars in saltire Or.*

Badge approved and forwarded to Laurel

Vincent Blackdragon (Dun Or) - New Name & New Device. *Argent, a dragon sable bellied gules maintaining two arrows inverted gules, a bordure sable mullet argent.*

Submitter desires a masculine name.

No changes.

Vincent is an English masculine given name found in FamilySearch Historical Records, including:

Blackdragon is a constructed English byname. From the registration of *Alicia Blackdragon* in May 2012:

There are multiple examples of bynames that combine a color and the name of an animal or monster: Margaret Makafee's "Comparison of Inn/Shop/House names found London 1473-1600 with those found in the ten shires surrounding London in 1636" adds 1585-1600 forms, including Black Beare, Black horse, Black eliphant, and Greene dragon. Examples of single word versions of such names in bynames can be found in the Middle English Dictionary, for example (s.n. red (adj)): Agn' atte Redcokke 1338.

Wintermist, Barony of - New Order Name & New Badge. *Order of the Noble Touch. (Fieldless) On a dexter glove aversant fesswise argent a snowflake gules.*

This is a long-standing honor given by Wintermist. We are requesting the help of the College in documenting the name.

The May 2015 LoAR notes that House of <full name of founder> is a valid pattern (see Brial Then de Raimes, <http://heraldry.sca.org/loar/2015/05/15-051ar.html#181>). Orders may be named after their founder or a saint.

Noble is found as a period given name and **Touch** is found as a period surname in FamilySearch Historical Records:

Assuming this is a valid pattern, it would be *Order of Noble Touch* (dropping "the").

Originally submitted as *(Fieldless) A dexter glove aversant fesswise argent*, this conflicted with Catriona nicHugh McLae (reg. April 2007 via the Middle), *(Fieldless) A hand fesswise argent*. The submitter was on hand (hah!) at the meeting, and approved the redesign.

The use of a snowflake gules is grandfathered to the submitter as both their device (*Gules, a laurel wreath Or, on a chief invected argent three snowflakes gules*) and a badge (*(Fieldless) A snowflake gules*) have snowflakes.

Order Name approved and forwarded to Laurel.
Badge approved and forwarded to Laurel with changes.

Wintermist, Barony of - New Order Name & New Badge. *Worshipful Company of the Silver Quill of Wintermist. (Fieldless) In bend sinister a quill bendwise sinister argent conjoined to a snowflake gules.*

Originally submitted as *Worshipful Order of the Silver Quill*, this conflicted with *Silver Quill Pursuivant*, registered to Atenveldt in June 1976. The submitter was present and agreed to add the locative “of Wintermist” to clear the conflict, as well as to change the designator to the more usual “Worshipful Company.”

The May 2008 Cover Letter states: "Silver in order and award names: The August 2005 cover letter says that "orders named for heraldic charges or for items that, while not found in period as heraldic charges, may be used as heraldic charges...may contain the ordinary color names of any heraldic tincture." This includes the use of **silver** as the ordinary color name of argent.

A **quill** is heraldic charge. This order name, then, follows the pattern of “color” + “heraldic charge.”

Originally submitted as *(Fieldless) A quill bendwise sinister argent*, this conflicted with the badge of the Barony

of Concordia of the Snows: (*Fieldless*) *A feather bendwise sinister argent* (May 2015 via the East). The submitter was present and approved the redesign.

The use of a snowflake gules is grandfathered to the submitter as both their device (*Gules, a laurel wreath Or, on a chief inverted argent three snowflakes gules*) and a badge (*(Fieldless) A snowflake gules*) have snowflakes. This is the group's seventh piece of armory. The shire will become a barony at Great Western War in October, therefore the armory limit will no longer apply.

Order name approved and forwarded to Laurel with changes.

Wöfel Bernhöft (Calafia) - New Name

Sound (no preferences marked) most important.

Both name elements are found in Bahlow but in undated forms. No further documentation could be found.

Name returned for lack of documentation.
