#### April Submissions

**Bernadette de Cabo de las Tormentas** – Kingdom Resub Name & Kingdom Resub Device. Sable, on a pale argent surmounted by a sun Or between in chief two mullets argent in chief a mullet sable.

No major changes. Desires a feminine name. Meaning (cape of storms) most important.

Submitter's previous name *Bernadette de Costa Tempestad* was returned by the Caid College of Heralds at their July 2015 meeting for lack of documentation. Her device *Sable, a pale argent surmounted by a sun and in chief three mullets counterchanged,* was returned for excessive counterchanging.

**Bernadette** is a French feminine given name found in "Names from Fourteenth Century Foix" by Cateline de la Mar. (http://www.s-gabriel.org/names/cateline/foix.html).

**Cabo de las Tormentas** is Spanish placename found in *Historia general de España* by Juan de Mariana

## Name approved and forwarded to Laurel.

Eduard Schade der Altere – New Name & New Device. Azure, a bend sinister sable fimbriated between a cloud argent and a flame Or.

No major changes. Desires a masculine name.

**Eduard** is masculine Dutch given name found in "Dutch Names 1358-1361" by Aryanhwy merch Catmael (<u>http://heraldry.sca.org/names/dutch/earlydutch14.html</u>).

Schade is a Dutch surname found in <u>http://heraldry.sca.org/names/dutch/dutch15surnames.html</u>.

**der Altere** is a German byname meaning "the Elder." *Ludwig de ältere* is found in "Kurtze Vorstellung von der wahren Beschaffenheit der hundert und sechzig Jahr an dem Kays. Cammer-Gerichte rechtshängig gewesenen Sache, über das von Graf Ludwigen zu Stollberg-Königstein und seinen dreyen Töchtern leiblich beschwohrne Pactum", published 1634. Per SENA Appendix C, Dutch and German name elements may be combined provided that they are dated to within 300 years of each other. Both German and Dutch allow for double bynames, per SENA Appendix A.

## Name approved and forwarded to Laurel.

Helgi hrafnfæðir - Appeal of Laurel Return of Badge. Fieldless, two ravens rising respectant sable maintaining between them two spears in saltire proper.

The submitter's previous submission of the same badge was returned by Laurel on the October 2014 LoAR for conflict:

This badge conflicts with the device of Thorfinnr inn vegsvinni Ingason: *Argent, two falcons rising wings addorsed respectant, maintaining between them a stone sable*. There is only one difference for fieldless versus fielded design. The posture is similar and no difference is granted for the conjoining of the birds or the maintained charges.

The submitter asks that the badge be reconsidered under the new ruling that maintained charges can count for difference.

# Badge approved and forwarded to Laurel.

**Morgant Fagan** – Kingdom Resub Device Change. *Sable, three talbot's heads couped and on a chief Or three grenades sable flamed gules.* 

If this device is registered, the submitter wants her old device, *Vert, a fess embattled Or between three decrescents argent and a talbot's head couped contourny Or,* to be released.

Her previous device change *Sable, a bend between a decrescent and a Talbot head couped Or* was returned at the November 2015 for conflict.

# Device change approved and forwarded to Laurel.

**Síthmaith inghean Stemni** – Kingdom Resub Name & Kingdom Resub Device. *Argent, in fess three billets checky gules and Or and a base rayonny sable.* 

Submitter desires a feminine name.

**Sithmaith** is an Old Irish Gaelic feminine given name found in "Index of Names in Irish Annals" by Mari Elspeth nic Bryan (Kathleen M. O'Brien)

(http://medievalscotland.org/kmo/AnnalsIndex/Feminine/Sithmaith.shtml) dated to 771, 773, and 778.

#### inghean - meaning 'daughter of'

**Stemni** is a Early Irish Gaelic form, dated to 1170 masculine name found in "Index of Names in Irish Annals" by Mari Elspeth nic Bryan (Kathleen M. O'Brien) (<u>http://medievalscotland.org/kmo/AnnalsIndex/Masculine/Stiamhna.shtml</u>) It is both the nominative and genitive form.

The submitter's previous name *Siomha ingen Stiofan* was returned by the Caid College of Heralds at July 2015 college meeting for lack of documentation and later resubmitted as *Síthmaith inghean Stiamna* at the March 2016 meeting, which was returned for name elements being outside the 500 year time limit. Fortunately the submitter is happy with the name we have documented, and allows whichever form of *inghean* is correct.

**Sonya Black Rune** – Kingdom Resub Device. *Or goutty de sang, a pomegranate gules, slipped and leaved vert.* 

Submitters previous submission of the same device was returned by the Caid College of Heralds at their March 2016 meeting for improper depiction of gouttes. This redraw addresses the reason for return.

## Device approved and forwarded to Laurel.

Stiamna mac Alusdair - Kingdom Resub Name.

Submitter desires a masculine name.

This name was considered at the October 2015 meeting and accidentally omitted from the Letter of Intent.

**Stiamna** is a masculine Middle Irish given name found in "Index of Names in Irish Annals" by Mari Elsbeth nic Bryan (http://medievalscotland.org/kmo/AnnalsIndex/Masculine/Stiamhna.shtml) dated in this spelling to 1316 and 1355.

mac is a masculine Early Modern Irish patronymic marker.

Alusdair is a masculine Early Modern Irish given name found in "Index of Names in Irish Annals" by Mari Elsbeth nic Bryan (http://www.medievalscotland.org/kmo/AnnalsIndex/Masculine/Alaxandar.shtml) dated in this spelling

to 1581.

While the fully Early Modern Irish form of the name would be *Stiamhna mac Alusdair*, we believe the submitted form is registerable.

## Name approved and forwarded to Laurel.

**Pýri Grímsdóttir** - New Name & New Device. *Per pale sable and azure, three chevronels braced and in chief an arrow fesswise argent.* 

No major changes. Sound (Thyri) most important. Language most important. Culture most important.

**Þýri** is an Old Norse feminine given name found on the "Old Norse Women's Names" by (<u>http://www.vikinganswerlady.com/ONWomensNames.shtml#thorn</u>) under the heading "Þyra, Thyra, Þýri":

Cleasby-Vigfusson says that Þyri is a weakened form of Þórvé, or the even older form Þórveig. GB pp. 17; FJ pp. 319, 347; CV pp. 690, 743 s.v. veig, Þórr; NR s.v. Þýrví/Þórvi, Þór-/Þúr-, -ví, -væig

*Grímr* is an Old Norse masculine given name found in Geirr Bassi on page 10. The patronymic form is **Grímsdóttir.**
