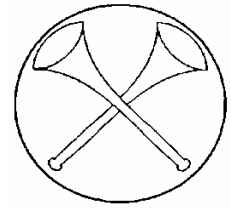

*Minutes of the July 10, 2016 Meeting*

Approved submissions were forwarded to Laurel on the July 31st, 2016 Letter of Intent.

**From Crescent:**

- Last year, the College of Scribes had Scribal Playday in Monrovia. Mistress Aliskye and I have scheduled a Scribal and Heraldic Playday this year for August 28<sup>th</sup> in Lyondemere.
- Great thanks are due to The Honorable Lady Angharat Goch verch Gwenhover, who completed her tenure as *Coral Pursuivant* yesterday at Lyondemere Anniversary. Angharat has found a worthy successor in The Honorable Lady Eliane Duran (*alias* Ky). Angharat will be continuing in her role as *Garb*. For the incoming and outgoing *Corals*: huzzah!
- Baroness Brianna Je Nell Aislynn of Blue Shadows, having served as capably and admirably these past two years as *Courtesy*, is seeking a successor. The *Courtesy* herald is a deputy to Crescent and is in many ways the chief court herald of the kingdom. The primary responsibility of *Courtesy* is to coordinate, advise, and support the Golden Rose heralds (the heralds selected by each Crown to be their official Voice). **July Submissions**

**Ariana verch Gwennlian - New Heraldic Will**

I, [REDCATED], known in the Society for Creative Anachronism, Inc. (SCA) as Ariana verch Gwennlian, wish to make the following determinations to my names and armory upon my death, as noted below:

- 
- Name: Ariana verch Gwennlian – Grant blanket permission to conflict with any names that are not identical.
  - Household name: Inn of the Tyger – Grant permission to conflict with the Kingdom of the East to create a heraldic title, if they request it.
  - Device: Argent, a pile bendwise Or – Grant a blanket permission to conflict with any armory that is not identical.
  - Badge: Per Bend Sinister argent and Or – Grant a blanket permission to conflict with any armory that is not identical.
  - Badge: Per pale argent and azure, in pale three mullets of seven points counterchanged – Release
  - Badge: (Fieldless) A tyger passant contourny argent. – Release

Done this 30th day of June in the year ASLI, or 2016 in the common reckoning.

**Batu Sechen Tsagaan - New Name**

Culture (Mongolian) most important.

Meaning (white Mongols (Tsagaan)) most important.

**Batu** - found as a name element meaning "loyal" in "On the Documentation and Construction of Period Mongolian Names" by Baras-aghur Naran: <http://heraldry.sca.org/names/mongol.html>

**Sechen** - found as a (female) given name meaning "girl" in Mongolian Naming Practices by Marta as tu Mika-Mysliwy, Brickbat Herald:[http://heraldry.sca.org/names/mongolian\\_names\\_marta.html](http://heraldry.sca.org/names/mongolian_names_marta.html) (not to be confused with identical 'Sechen' as an epithet meaning 'wise')

**Tsagaan** - found as a clan/tribal name meaning 'white Mongols,' in the same source

This name takes the pattern 'n+n' + clan identification, as described in "On the Documentation and Construction of Period Mongolian Names." This means that the first two name elements (Batu + Sechen) combine to form a name phrase that must make sense logically in its meaning (loyal girl), followed by the final name which designate the clan (white Mongols).

**Coralina Waters** - New Name & New Device : *Per bend sinister sable and argent, a cross elongated to chief argent and a raven volant to base sable holding in its beak a heart gules.*

**Coralina** is found as a German feminine given name in FamilySearch Historical Records dated to 1578:

Coralina Eberlin Gender Female Christening 30 Nov 1578 Stuttgart, Württemberg, Germany Father Daniel Eberlin Mother Coralina C91613-1 <https://familysearch.org/ark:/61903/1:1:NHBK-QT5>

**Waters** is found as an English surname on the same site:

Elizabeth Waters 1579 SWAFFAM PRIOR, CAMBRIDGE, ENGLAND Father's Name William Waters C13835-1 <https://familysearch.org/ark:/61903/1:1:N8L7-H2Z>

The Cover Letter to the February 2015 LoAR states:

Therefore, we will not add the English-German lingual mix to Appendix C of SENA. However, we will allow the borrowing of given names from German into English and vice versa, in the context of the 16th and early 17th centuries. An English given name that is borrowed from German is considered to be English under Appendix C, and a German given name that is borrowed from English is considered to be German.

Therefore, these name elements are combinable as an English name.

No paperwork was received for this device (although payment was received).

**Coralina Waters** - New Badge. (*Fieldless*) *A cross elongated to chief overall a corvus striking.*

No paperwork was received for this badge (although payment was received).

**Geiri Smiðsson** - New Name.

**Geiri** - Found as a male given name in Norse context in Geirr Bassi p. 10 s.n. Geiri

**Smiðsson** - Smiðr is found as a male given name in Norse context in Geirr Bassi p. 14 s.n. Smiðr, submitter requests authenticity for constructing correct patronymic for this given name. Construction of the genitive appears correct, per Geirr Bassi p. 17.

Submitter would also like confirmation from an expert on Norse names as to the correct pronunciation for both name elements.

**Griffith von Bremen** - New Device. *Argent, a rermouse sable, maintaining in its feet a sword fesswise gules, hilted Or.*

The drawing of this device that appeared in Kingdom commentary raised questions about whether or not it was a period depiction of a sword. The College agreed that it was a problematic depiction of the sword, and redrew the hilt with the submitter's permission.

**Gyldenholt, Barony of** - Appeal of Kingdom Return of Order Name. *Citrine, Order of the*

This submission is to be associated with *Azure, a hexagonal gemstone Or.*

No changes.

This Order Name was returned by the Caid College of Heraldry at their May 2012 meeting for lack of documentation of the order name pattern.

Citrine is found in the OED as a semi-precious stone (yellow quartz) dated to the 16th C:

1571 in A. Feuillerat Documents Office of Revels Queen Elizabeth (1908) 139 Stones called Sitterines and Topiasses with enamellings.

The Barony argues that this order name follows the pattern of taking the name of an item of regalia, as attested in 'Medieval Secular Order Names: Standard Forms of Order Names' by Juliana de Luna (<http://heraldry.sca.org/names/order/new/ListingOfStandardForms.html#AllRegalia>). In Gyldenholt's case the Citrine semi-precious stone is given as regalia with the award. They are invoking *Lingua Anglica* to change the period documented spelling 'sitterine' to the modern English 'citrine.'

The College of Heraldry reviewed the examples provided of orders named for regalia, and except for the Sign (senyel/cinyel) all are garments or parts of garments. We find no evidence of gemstones in provided documentation being used as Order names in their own right. The February 2008 registration of the *Order of the Blue Pearl* for the Barony of Terra Pomaria might provide an example to follow, but it was registered without comment. As such, the College was undecided on this matter.

**Gyldenholt, Barony of** - Resub Laurel Return of Badge. (*Fieldless*) *On an orange stemmed and leaved, an orange blossom proper.*

This submission is to be associated with *Orange Blossom, Order of the*

The original badge submission, *Azure, an orange blossom proper*, was returned in the August 2012 LOAR for conflict with Titus of Wormwood, *Purple, a cinquefoil slipped and singly leaved argent*. A subsequent resubmission *Azure, an orange blossom argent within and terminating a capital letter "G" Or*, was returned by the Caid College of Heraldry in October 2012 for redraw, noting "The orange blossom is equivalent to a maintained charge, making this a single abstract charge, which is not registerable."

Appearing in Kingdom commentary as (*Fieldless*) *An orange blossom stemmed and fruited proper*, the particular depiction used was unable to be properly blazoned. With the submitter's permission, it was redrawn as (*Fieldless*) *On an orange stemmed and leaved, an orange blossom proper.*

**Hammash Mathan Mor** - Resub Laurel Device. *Sable, a bear rampant to sinister argent and a bordure compony gules and argent.*

This is a resubmission of the submitter's device which appeared on the Caid June 2016 LoI and was withdrawn.

**Jonathan Green Bear** - New Name & New Device. *Argent, a bear paw print bendwise vert and a bordure purpure.*

**Jonathan** is an English male given name found in FamilySearch Historical Records:

Jonathan Hardinge to Spouse Mary Quintin 1609, St Andrew, Chardstock, Devon, England M06009-1;

**Green** is found as an English surname in FamilySearch Historical Records:

**Bear** is found as an English surname in FamilySearch Historical Records:

**Keinvryd ferch Talan** - New Badge. *(Fieldless) A calygreyhound dormant vert.*

Depictions of any dormant creatures are difficult. The elevation of the distinctive antlers, the most defining feature of the calygreyhounds, was a brilliant move by the artist. Commenters unfamiliar with the creature were able to look at the line art and identify all of the salient features of the calygreyhound listed in the PicDic without prompting.

**Molly of the Crossroads** - New Device. *Per pale argent and azure, a latin cross flory between four harps counterchanged*

This device was returned by the Caid College of Heraldry at their October 2014 meeting for conflict with Aaliz de Gant, *Per pale argent and azure, a cross flory between four fleurs-de-lys counterchanged* (August 2014, AEthelmearc). Aaliz has granted permission to conflict.

**Nauuen Whyte Wolf** - New Name & New Device. *Per pale sable and argent a stag and a domestic cat combattant and in base a roundel per pale Or and gules*

**Nauuen** is an English given name found in *Domesday Book of Names* by Keats and Thornton.

**Whyte** is found in R&W under the header White pg 486 *Walter le Whyte* 1284 likely meaning dweller by the curve in the river or road

**Wolf** is found in R&W and is header spelling. *John le Wolf* dated to 1279 a nickname from the wolf

**Paul fitz Denis** - New Household Name. *Maison du Bouc d'argent.*

Meaning (house of the white/silver goat) most important.

The pattern of <designator> <charge> <color> in French inn names is found in "Inn Signs and House Names in 15th Century Paris" by Juliana de Luna (<http://medievalscotland.org/jes/ParisInnHouseNames/>) with examples:

- la maison du Chapeau rouge (house of the red hat)
- enseigne la Barbe d'or (sign of the gold beard)
- hostel du Lion d'argent (house of the white lion)

**Bouc** is the French word for a goat, found in a French edition of the Bible published 1569, (<https://books.google.com/books?id=cKqhuI6u CZcC&pg=RA3-PT11&dq=cinq+bouc&hl=en&sa=X&ved=0ahUKEwiOwb3J oOTNAhWB7yYKHSr9Co8Q6AEIODAE#v=onepage&q=cinq%20bouc&f=false>) in Numbers 7:71:

Et pour le sacrifice de pacifiques deux boeufs, cinq moutons, cinq boucs, et cinq agneaux d'un an.

which is in English:

And for the sacrifice of peace offerings, two oxen, five rams, five goats, and five lambs one year old.

**Sigbiorn Sigmundarson** - New Badge. *(Fieldless) A bear's paw erased appaummy argent.*

We do not believe that there is a conflict with Fearghus O'Shannon *(Fieldless) A tiger's jambe couped argent, marked sable*. There is definitely one DC for fieldless, and we could find no precedent stating that jambs are jambs, giving at least as second DC if not an SC for change of type of charge.

**Steve of Silvercreek** – Laurel Resub Laurel Device. *Argent, three fish fretted in triangle within a bordure wavy vert.*

The submitter's previous device, *Argent, three fish fretted in triangle vert*, was returned by Laurel in the January 2016 for conflict with the device of Katelinen van Walravenshyde, *Argent, three fish naiant in annulo dorsal fin to center vert*, saying "There is one DC for the change of arrangement but no other DC." The addition of the bordure gives the second DC needed to clear this conflict.

### **Þorinn inn rauði refr** – Kingdom Resub Name (Edit) (Delete)

The submitter's previous submission *Þorinn inn rauði* was returned in June 2016 by the Caid College of Heraldry for conflict with *Þorfinnr inn rauði*, registered 2/2015.

**Þorinn** is an Old Norse masculine given name. From the registration of **Þorin** Stáli, (January 2013, Ansteorra):

Thorin is documented as an Anglo-Norse or Old English name. Either could be spelled with a thorn, so the name is fine as submitted. The submitter may want to know that the typical Old Norse spelling is Þorinn. (<http://heraldry.sca.org/loar/2013/01/13-01lar.html#29>)

**inn rauði** is a byname found in Geirr Bassi, p. 26, meaning "red".

**refr** is byname found in Geirr Bassi, p. 26, meaning 'fox'

From May 2012 LoAR for return of *Sorcha rauðrefr*:

"One solution for the Old Norse bynames is to use two different bynames: one meaning "red" and another meaning "fox." This would be *in rauða refr*"

---

### **Wiot la Souris** - New Name.

Submitter allows all changes and indicates no preferences.

**Wiot** is found as an English male given name in R&W under the header Wyatt as in Wiot de Acham dated to 1192. Wiot is a diminutive form of William. Submitter will accept other spellings of Wiot if required to register.

**la Souris** is a constructed French byname meaning “the mouse” based on the pattern of animal descriptive bynames found in *DRAFT: Names in the 1292 census of Paris* by Sara L. Uckelman (<http://www.ellipsis.cx/~liana/names/french/1292paris.pdf>) including la Vache (the cow, p. 155), le Rat (the rat, p. 152), le Chat (the cat, p. 139), and le Singe (the monkey, p. 153). This is the modern French spelling of the word; we ask the assistance of the College of Arms in determining the period spelling.

English and French name elements are combinable by SENA Appendix C.
